KATHUA GANGRAPE-MURDER

AN FIR has been registered 46-yr-old Krishnasamy made a 500 kagainst Hindu Ekta Manch president and former state secretary of the BJP Vijay Kumar Sharma and two others in connection with an attack on the cavalcade of Jammu and Kashmir Minister Sham Lal Choudhary, the police

> said on Sunday. The BJP minister's convoy was attacked at Kootah Morh, along the Jammu-Pathankot naighway, allegedly by the fives of the eight men, ar

rested by the Crime Branch of the state police in the Kathua gangrape and murder case, and their supporters on Saturday, who are seeking an investigation by the CBI into the matter. The attack came just two days before the Supreme Court is scheduled to hear on a petition seeking CBI inquiry into the matter on Monday.

The police told The Indian Express that three of the attackers have been identified as former sarpanch of Kootah and Hindu Ekta Manch (HEM) Kant Sharma and Raj Khajuria, besides Sharma. No arrest has been

made so far.

According to Choudhary was on his way to chair a meeting of the District Development Board in Kathua Saturday when the agitators blocked his convoy and showed black flags. The mob also pelted the vehicles with stones, leaving window panes of some cars damaged, and shouted slogans seeking CBI probe into the case.

The minister escaped unhurt as the police intervened and dispersed the mob within five minutes, the police said. Choudhary could not reached for comments on the attack.

S Krishnasamy, a resident of Thiruthuraipoondi in Tamil Nadu, had to travel over 500 kilometres to reach Ernakulam on Saturday, where his son Kasthoori Mahalingham K was allotted a centre to appear for NEET-2018 the next day.

## 'Police picked up, killed U

THE ONLY eyewitnesses to the shootout between two alleged criminals and the UP Police on Muzaffarnagar-Thana Bhawan Road late on Thursday are the police themselves.

Two individuals who might have been present along the stretch lined with mango orchards and sugarcane and wheat fields, weren't there - 35-year-old tubewell operator Waseem, and 60-year-old Mukesh, who was tilling land next to the dirt lane in which the encounter happened, had both gone home early.

18-year-old Rehaan was shot dead by a police SWAT team comprising a sub-inspector and five constables. According to police, Rehaan was a member of the Mukeem Kala gang, who was wanted for crimes including murder, and carried a reward of Rs 50,000 on his head.

This was the 50th encounter killing of an alleged criminal in UP since the Yogi Adityanath government took over in March 2017. A constable of the SWAT team, Harvinder, sustained
