Toll Revenue for Q1FY18

Toll revenue received from the below 10 operational SPVs (apart from NSEL which is an annuity project) have increased by approx 15.6% to Rs. 2,430.0 mn in Q1FY18 from Rs. 2,101.2 mn in Q1FY17.

ARRIL – Toll revenue received in Q1FY18 has reduced by approx 1.0% to Rs. 234.3 mn from Rs. 236.7 mn in Q1FY17.

AJTL - Toll revenue (excluding cars and state buses) received in Q1FY18 has reduced by approx 7.1% to Rs. 92.5 mn from Rs. 99.6 mn in Q1FY17.

BHTPL - Toll revenue received in Q1FY18 has reduced by approx 2.6% to Rs. 295.9 mn from Rs. 303.9 mn in Q1FY17.

HYTPL - Toll revenue received in Q1FY18 has increased to Rs. 171.1 mn from Rs. 148.7 mn in Q1FY17.

MBCPNL - Toll revenue received in Q1FY18 has increased by approx 8.6% to Rs. 451.1 mn from Rs. 415.3 mn in Q1FY17. During Q1FY18, 16 Check Posts were generating revenue while during Q1FY17 13 Check Posts were generating revenue.

DPTL - Toll revenue received in Q1FY18 has increased by approx 2.1% to Rs. 426.4 mn from Rs. 417.5 mn in Q1FY17.

RPTPL – Toll revenue received in Q1FY18 has increased by approx 20.8% to Rs. 247.1 mn as against Rs. 204.6 mn in Q1FY17.

SUTPL – Toll revenue received in Q1FY18 has increased by approx 4.3% to Rs. 262.8 mn as against Rs. 252.0 mn in Q1FY17.

BRTPL - Toll revenue received in Q1FY18 stood at Rs. 116.2 mn as against Rs. 23.0 mn in Q1FY17. Toll collection started from 9^{th} June, 2016.

RHTPL - Toll revenue received in Q1FY18 stood at Rs. 132.4 mn. Toll collection started from $3^{\rm rd}$ August, 2016.
