## **Toll Revenue for Q2FY18**

Toll revenue received from the below 10 operational SPVs (apart from NSEL which is an annuity project) have increased by approx 12.0% to Rs. 2,401.7 mn in Q2FY18 from Rs. 2,144.0 mn in Q2FY17.

**ARRIL** – Toll revenue received in Q2FY18 has reduced by approx 0.2% to Rs. 226.6 mn from Rs. 227.0 mn in Q2FY17.

**AJTL** - Toll revenue (excluding cars and state buses) received in Q2FY18 has reduced by approx 2.4% to Rs. 86.2 mn from Rs. 88.3 mn in Q2FY17.

**BHTPL** - Toll revenue received in Q2FY18 has increased by approx 3.9% to Rs. 296.7 mn from Rs. 285.6 mn in Q2FY17.

**HYTPL** - Toll revenue received in Q2FY18 has increased by approx 26.7% to Rs. 158.5 mn from Rs. 125.1 mn in Q2FY17.

**MBCPNL** - Toll revenue received in Q2FY18 has increased by approx 6.4% to Rs. 432.2 mn from Rs. 406.3 mn in Q2FY17. During Q2FY18, 16 Check Posts were generating revenue while during Q2FY17 13 Check Posts were generating revenue.

**DPTL** - Toll revenue received in Q2FY18 has increased by approx 10.6% to Rs. 440.8 mn from Rs. 398.5 mn in Q2FY17.

**RPTPL** – Toll revenue received in Q2FY18 has increased by approx 29.4% to Rs. 250.1 mn as against Rs. 193.3 mn in Q2FY17.

**SUTPL** – Toll revenue received in Q2FY18 has increased by approx 8.8% to Rs. 264.7 min as against Rs. 243.3 mn in Q2FY17.

**BRTPL** - Toll revenue received in Q2FY18 has increased by approx 17.8% to Rs. 110.3 mn as against Rs. 93.7 mn in Q2FY17.

**RHTPL** - Toll revenue received in Q2FY18 stood at Rs. 135.5 mn. Toll collection started from  $3^{rd}$  August, 2016.
