## Toll Revenue for Q4FY17

Toll revenue received from the below 10 operational SPVs (apart from NSEL which is an annuity project) have increased by approx 17.9% to Rs. 2,382.7 mn in Q4FY17 from Rs. 2,020.9 mn in Q4FY16.

**ARRIL** – Toll revenue received in Q4FY17 has reduced by approx 2.7% to Rs. 239.6 mn from Rs. 246.2 mn in Q4FY16.

**AJTL** - Toll revenue (excluding cars and state buses) received in Q4FY17 has increased by approx 3.6% to Rs. 90.9 mn from Rs. 87.7 mn in Q4FY16.

**BHTPL** - Toll revenue received in Q4FY17 has reduced by approx 3.1% to Rs. 292.8 mn from Rs. 302.2 mn in Q4FY16.

**HYTPL** - Toll revenue received in Q4FY17 has marginally reduced to Rs. 153.1 mn from Rs. 153.2 mn in Q4FY16.

**MBCPNL** - Toll revenue received in Q4FY17 has increased by approx 3.9% to Rs. 448.3 mn from Rs. 431.5 mn in Q4FY16. During Q4FY17, 13 Check Posts were generating revenue till 26<sup>th</sup> January, 2017 while 16 Check Posts were generating revenue from 27<sup>th</sup> January, 2017. During Q4FY16 13 Check Posts were generating revenue.

**DPTL** - Toll revenue received in Q4FY17 has increased by approx 14.8% to Rs. 449.1 mn from Rs. 391.1 mn in Q4FY16.

**RPTPL** – Toll revenue received in Q4FY17 has increased by approx 24.2% to Rs. 224.7 mn as against Rs. 180.9 mn in Q4FY16.

**SUTPL** – Toll revenue received in Q4FY17 has increased by approx 9.4% to Rs. 249.7 mn as against Rs. 228.2 mn in Q4FY16.

**RHTPL** - Toll revenue received in Q4FY17 stood at Rs. 130.0 mn. Toll collection started from  $3^{rd}$  August, 2016.
